

COMPOSIGRIP LIMITED WARRANTY

Comoldco Corporation (hereinafter referred to as 'CMC'), manufacturer of ComposiGrip products, warrants to the original purchaser that, for the period of time set forth below, under normal use and service conditions, ComposiGrip products shall be free from defects in workmanship and materials, and shall not split, splinter, rot or suffer structural damage from termites or fungal decay, provided that this limited warranty shall not apply to any materials which have been subject to accident, improper handling, improper installation, improper maintenance, improper repair or alteration, or used in any way contrary to good standards of practice within the building industry. The term of such warranty shall be as follows:

Steps:

Twenty-five (25) years from the date of original purchase for a residential purchaser
Ten (10) years from the date of original purchase for a commercial purchaser

Step Covers/Stair Treads, Flat Strips:

Five (5) years from the date of original purchase for all purchasers

Definitions: For purposes of this warranty, a 'residential purchaser' shall refer to an individual residential homeowner, and a 'commercial purchaser' shall refer to any purchaser other than a residential purchaser.

If a defect occurs within the warranty period, Purchaser shall notify CMC in writing, accompanied by an original receipt and request a 'Product Return Code'. No product shall be returned without a Product Return Code which shall be clearly marked on returned shipment. Upon confirmation by an authorized CMC representative that the defect is the result of defective materials or defective workmanship, CMC's sole responsibility shall be, at its option, to either replace the effective item or refund the portion of the purchase price paid by Purchaser for such defective item (not including the cost of its initial installation, removal of defective products or installation of replacement product including but not limited to labor and freight).

This Limited Warranty is expressly made in lieu of any and all other warranties, express or implied, including without limitation, any implied warranty of merchantability or fitness for a particular purpose. Refund of purchase price or repair or replacement of defective goods as provided above shall be the purchaser's sole and exclusive remedy for contract, warranty, negligence, tort or strict liability claims. Under no circumstances shall CMC be liable for any special, indirect, incidental, economic or consequential damages of any character (including but not limited to loss of use, lost profits, loss of business, business interruption, or attorney's fees) caused or alleged to be caused in whole or in part by the negligence, tort, strict liability, breach of contract, breach of warranty or other breach of duty of or by CMC. This warranty does not cover damage of any sort resulting from faulty installation, misuse, fire, neglect, movement or settling, distortion or collapse of the ground or supporting structure on which the ComposiGrip products are installed, naturally occurring casualties including impact of objects, earthquakes, tornadoes, hurricanes, lightning, flooding or acts of God; improper handling or storage, neglect or misuse of the products or normal weathering of surfaces.
